ORDER

CHANGE OF NAME OF THE INSTITUTION AND AFFILIATING BODY

WHEREAS the recognition was granted to the institution namely **Uttaranchal College of Education**, Prem Nagar, 10, Gandhi Road, Dehradun-348001 Uttaranchal for conducting B.Ed. course of one-year duration with an annual intake 100 students from the academic session 2006-2007 vide order No. **F.NRC/NCTE/F-7/UR-61/4661-4670** dated **11.08.2006** followed by the revised recognition order for B.Ed. course for two-year duration with an annual intake of 100 seats vide order dated **25/05/2015**.

2. **AND WHEREAS**, the name of the sponsoring society of the above institution i.e. Sri Sri 1008 Narayan Swami Charitable Trust, Narayan Village, P.O.-Nanda ki Chowki, Prem Nagar, Dehradun-248001, Uttarakhand established on 12.08.2002 was changed as Dr. Jagat Narain Subharti Charitable Trust given vide amended and corrected trust deed dated 15.09.2011, registered in the office of Sub Registrar, Vikas Nagar, Dehradun on 15.09.2011.

3. **AND WHEREAS**, the Government of Uttarakhand passed an Act namely Ras Bihari Bose Subharti University Act No. 35 of 2016 wherein it has been mentioned: -

"(r) Trust means Dr. Jagat Narain Subharti Charitable established on 12.08.2002 by the name of Sri Sri 1008 Narayan Swami Charitable Trust and the new name Dr. Jagat Narain Subharti Charitable given vide amended and corrected Trust Deed dated 15.09.2011 which was registered in the office of Sub Registrar Vikas Nagar, Dehradun on 15.09.2011. Therefore, all the properties registered under the name of Sri Sri 1008 Narayan Swami Charitable Trust comes under the ownership of Dr. Jagat Narain Subharti Charitable Trust."

4. **AND WHEREAS**, the Society has requested NRC to change the name of institution located in the campus of Ras Bihari Bose University and to change the affiliating body.

5. **AND WHEREAS**, the matter was placed before NRC in its 418th Meeting held on 23rd to 24th January 2024, the Committee considered the representation of the institution dated 13.02.2024 & 22.02.2024 and the Committee decided as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines, and Visiting Team Report issued from time to time were placed before the Northern Regional Committee. The NRC made the following observations:-

The first Show Cause Notice u/s 17 of NCTE Act dated 05.10.2023 was issued to the institution for submission of compliance of adherence of conditions of NCTE Regulations, 2014 and as stipulated under the Provisional Revised Recognition Order dated 25.05.2015. The institution submitted a reply of first SCN vide its letter dated 18.10.2023.

The Committee decided that a Final Show Cause Notice before withdrawal of recognition of B.Ed. course under Clause 17 of NCTE Act, 1993 be issued to the institution for submission of compliance with a period of 07 (seven) days from the date of issue of Final SCN on the following grounds: -

The institution is directed to submit the following: -

- i. BCC submitted by the institute is not approved by the competent authority.
- ii. The institute submitted a proforma of 16 faculty signed and approved by the Registrar RBBS University, but the date of approval is not mentioned own the proforma. Further 5 faculty namely Mr. Subhash, Kr. Pratibha, Ms. Sangeeta, Mrs. Asha and Mrs. Usha Rani are not qualified as per NCTE Regulation 2014 (amended vide notification dated 09.06.2017) as they do not possess NET qualification.
- iii. Administrative and professional staff have not been appointed as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014.
- iv. The institute did not submit bank statements duly certified the bank in respect of Account of college and all individual faculty and other staff for last 3 months as required under clause 10(2) of NCTE Regulations, 2014 showing disbursement of salary through bank account.
- v. The institution has not submitted the additional information as per Clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.
- vi. Building Plan submitted is not legible. Further earmarked area for all courses being run in the University on the building plan not submitted.
- vii. The institution has submitted FDR's copy along with Form "A" which is expired. (Pg. No. 924-926). The institution is required to submit a renewed FDR's copy and Form "A".
- viii. The institution is required to submit a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution / society."

6. **AND WHEREAS**, the reply from the institution was placed before NRC in its 439th meeting held on 05th & 06th May 2025 and the Committee decided as under: -

"The Original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely Uttaranchal College of Education, Prem Nagar, 10, Gandhi Road, Dehradun-348001, Uttarakhand

managed by the Sri Sri 1008 Narayan Swami Charitable Trust, Narayan Village, P.O.-Nanda ki Chowki, Prem Nagar, Dehradun-248001, Uttarakhand for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2006-2007 vide order No. F.NRC/NCTE/F-7/UR-61/4661-4670 dated 11.08.2006 followed by the revised recognition order for B.Ed. course of two year duration with an annual intake of 100 seats vide order dated 25/05/2015.

- Sri Sri 1008 Narayan Swami Charitable Trust was established on 12.08.2002 and vide amended and corrected trust deed dated 15.09.2011, the name of trust was changed as Dr. Jagat Narain Subharti Charitable Trust.
- The Government of Uttarakhand has passed the Ras Behari Bose University Act No. 35 of 2016 wherein it has been mentioned: -

“(r) Trust means Dr. Jagat Narain Subharti Charitable Trust established on 12.08.2002 by the name of Sri Sri 1008 Narayan Swami Charitable Trust and the new name Dr. Jagat Narain Subharti Charitable Trust given vide amended and corrected trust deed dated 15.09.2011 which was registered in the office of Sub-Registrar Vikas Nagar, Dehradun on 15.09.2011. Therefore, all the properties registered under the name of Sri Sri 1008 Narayan Swami Charitable Trust comes under the ownership of Dr. Jagat Narain Subharti Charitable Trust.”

- The Uttaranchal College of Education, being run by the aforesaid Trust, is situated within the campus of Ras Bihari Bose Subharti University.
- The institution has submitted the NOC from HNB Garhwal University for disaffiliation and becoming the Faculty of Education under Ras Bihari Bose Subharti University.
- The society vide letter dated 29/04/2025 has requested the Northern Regional Committee to change the name of the institution located in the campus of Ras Bihari Bose Subharti University as the Department of Education, Ras Bihari Bose Subharti University and to change the affiliating University. “

In view of the above, the Committee permitted as under:


- (a) The name of the institution be changed from Uttaranchal College of Education, Prem Nagar, 10, Gandhi Road, Dehradun-348001, Uttaranchal to the Department of Education, Ras Bihari Bose Subharti University, Prem Nagar, 10, Gandhi Road, Dehradun-348001, Uttarakhand for offering B.Ed. Course with an annual intake of 100 seats i.e. two units of 50 students each.
- (b) The affiliating body be changed from HNB Garhwal University to Ras Bihari Bose Subharti University, Prem Nagar, 10, Gandhi Road, Dehradun-348001, Uttarakhand for B.Ed. Course.

Orders be issued accordingly.

7. NOW THEREFORE, in terms of the above decision of NRC, the institution is hereby accorded permission for the following for offering its B.Ed. course with an annual intake of 100 students i.e. two basic units of 50 students each: -

- i. To change the name of the institution from Uttaranchal College of Education, Prem Nagar, 10, Gandhi Road, Dehradun-348001 Uttaranchal to the **Department of Education, Ras Bihari Bose Subharti University, Prem Nagar, 10, Gandhi Road, Dehradun-348001 Uttarakhand.**
- ii. To change the affiliating body from HNB Garhwal University, Sri Nagar, Uttarakhand to **Ras Bihari Bose Subharti University, Prem Nagar, 10, Gandhi Road, Dehradun-348001 Uttarakhand.**
